Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from ***Silay City Water District*** and inspect the Bidding Documents at the address given below from ***9:00 AM – 4:00 PM***.
5. A complete set of Bidding Documents may be acquired by interested bidders on ***July 30, 2024 until August 19, 2024*** from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ***Five Thousand Pesos Only (Php 5,000.00)***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile or through email.
6. The ***Silay City Water District*** will hold a Pre-Bid Conference on ***August 07, 2024, 02:00 P.M.*** at ***Silay City Water District Board Room***, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **2:00 P.M. on August 19, 2024**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **2:05 P.M. on August 19, 2024** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Silay City Water District** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
